

**BYLAW 841  
OF THE VILLAGE OF BIG VALLEY  
IN THE PROVINCE OF ALBERTA**

**Being a bylaw of the Village of Big Valley to repeal Bylaw 833 and amend Bylaw 801 regulating and providing for the terms, conditions, rates and charges for the supply and use of water and waste water services provided by the Village of Big Valley**

WHEREAS the Council of the Village of Big Valley, in the Province of Alberta, deems it necessary to repeal Bylaw 833, and amend Bylaw 801 to update charges to better reflect current market costs;

NOW THEREFORE the Council of the Village of Big Valley, in the Province of Alberta in open meeting assembled enacts as follows:

1. THAT Schedule A be amended as follows:


1. Metered Rates

2. THAT the above rates are to be effective as of January 1, 2019.
3. THAT Bylaw 833 is hereby repealed and this Bylaw shall take effect upon the date of its adoption by Council.




